

## **Resolution to Dissolve Trust -- Exhibit 2**

Wow,

What a freakin' trip this is. I'll review those Articles, and Sections you've cited, and respond in a moment.

For now, understand two things:

1) A major life move/relocation is a PTSD-inducing experience when the particulars of such a move are beyond one's control for more than 60 days. Last day of July, Spirit tells me, (paraphrased) "Go to Minneapolis; now", as in that night, and I did so with absolutely zero certainty about anything. It was a difficult transit; lotta stress, lotta edge. I get here, and the doggone freeway system is as unnerving as San Diego's, but more extensive, and every day is stress, stress, stress. What you perceive as "nastiness" is a combo of my distrusting you because of the verbal attack that below referred to, and the natural outcome of a person in a desperate position, 2000 miles away from home. Likening it to scaling El Capitan solo, I'm way the bleep up here, it's windy AF, and, you, knowing what I'm transiting expect

me to demonstrate a tone of communication that doesn't evident a mote of edginess.

2) We may end up agreeing there is a conflict of interest, although I firmly believe, and have worked to ensure there is not, however, my affecting a possible conflict of interest, as cause for the actions you're attempting to take, do not in any way dismiss you from taking the steps delineated in Article XVIII. You need first informally approach the person, and detail your concerns, and give her, or him time to effectively respond. Then, if no response has been forthcoming, present your case, AND, evidence of your having made the first mandatory communication to another of the I Tarainimi. If that person agrees with you that disciplinary action MAY be appropriate, then the further steps of that Article must be taken, sequentially. In all of your documentation, you have nothing that equates with your having taken that first step. That only thing you have in our correspondence is relative to our recent communication about

what I perceived as the difference between the offline, and online Tengwar rendering; and, in that communication, I was clearly willing to accommodate rectifying what's reasonable for me to rectify-considering the involuntary, and unintentional nature of my Tengwar rendering

mistake(s). Rectifying the circular Tengwar by hand is unreasonable, that was stated, the projected costs of having them professionally rendered were therein shared, hence, I circumspectly, and positively responded to your communication about withholding those products, nonetheless arguing my disagreement. Hence, while I need to review those below citations you've provided to determine if they do, in the legal sense of the Bylaws affect a conflict of interest, I must also abide by the Bylaws by having informed you that, lacking any written, or phone evidence of your approaching me about any of your Elvenchrist concerns, and about your concerns about my tone of communication, since our previous phone conversation, which was the one to which I below referred, and prior to your below "DEMAND", you're in direct violation of that Article. As a leader, please see that, as simply as it is; and please see my calling you out the way I have as a simple, mandatory response to your lack of such evidence, and let's walk away from making this more of a legal, documented entanglement.

Let go. I've nothing wrong, or in conflict with any aspect of the Trust because I have not used any of the Trust's resources to affect any iota of Elvenchrist, nor have I represented Elvenchrist as an entity that's associated with T-e in any other way, but my personage. Now, IF our Bylaws may be construed to apply to having a Redbubble store competition with T-e, then that's rectifiable, and I have already below presented the solution that anticipated your below message by more than 72 hours--hence, demonstrating that, AS a trustee, I was also aiming to steer Elvenchrist away from any possible conflict of interest with respect to the Redbubble-based presentation. Having already resolved 95% that, on my back end, I intended to spend all of the hours I have been dealing with this miasma by removing the Redbubble pieces from the Elvenchrist home page, and, and Iluvamil's FB profile, and substituting them with the newer store images. I could have been done with that hours ago, and because of all this, I haven't even begun the first piece of that.

By the way, with respect to your assertions that Jesus is not in the Legendarium, and therefore, Elvenchrist is part of my alleged conflict of interest, that would only apply if I was trying to assert Elvenchrist anything within T-e presentations. The closest I've come to that is my sharing the store image on the T-e FB page, which is completely under your control to remove, given your perspective of such conflict. If you did so, I'm okay with that.

For the sake of arguing in favor of your perspective, [in an unbinding way, since I haven't read your citations yet], let's say that your most recent response applies to the first step in Article XVIII, and you've informed me that my having another Redbubble store for Elvenchrist is a conflict of interest. My now responsibility would be to remove the Redbubble content from any presentations that T-e supports. T-e is not supporting any of my presentations, other than those I've formally shared through ElvenSpirituality.com; so, I would have to respond that your perspective is errant, however, with the intention of doing so, because i have found a much better supplier for my very different business model, that's going to happen any way.

## What are you really afraid of?

I'm not trying to take T-e in any askance direction, so that need not be a concern. Frankly, the weight of all that I need to do as an administrator is heavy on me, and I really need to be overwhelmingly focused on that, and to do that, I need to make a solid new base from which I may consistently give the necessary attention to that collective duty. The single most important piece is the Music Ministry piece, and that's not gonna happen until all of the Operations pieces are together. You have the T-e store, and you may build it as you wish; it's business model mainly is based on giving T-e community

what they previously said they like. Elvenchrist is an entirely different direction, and, frankly, having told my son that my intention for the domain was to release Iluvamil music, I was surprised when Spirit directed me to go into the store direction. HER intention for my doing so seems to be largely driven by both Her interest in reaching the represented demographic, with the benefit of possibly enabling me to restore the funds I directed into T-e without presssuring T-e about it.

If I was errant, in any way, I would not have the deep, lingering Peace [that remains undeterred by the below storm you've blown in my direction] that I have had throughout this communication. I have repeatedly, and objectively as possible, looked within myS'Elf to see if you're correct about any of your below suppositions, and I come up empty; the Truth of my intentions, motivations, and behavior is entirely inconsistent with all of your suppositions.

Speaking frankly, I'm in a motherfucker of a life situation over here, and I'm trying to handle my shit for my sake, and for T-e's. I put out for T-e, and I will update those Valar Tengwar, but, other than that, I don't need to justify my Iluvamil perspective, and actions against anything I stand for within T-e, because the two are not collaborating--there is no legal relationship between the two, so what I do with Iluvamil is no different from what Kimberel was doing with her independent operation. Same criteria that applied to her apply to me; if I'm not trying to introduce Elvenchrist anything into any T-e documentation, and if Elvenchrist is not using any visual elements consistent with those owned by T-e, there is zero literal conflict of interest.

Now, also, please understand this: In order for me to establish consistency of attention to the key pieces of my DOO+Treasurer role, I have set aside the last Wed.-Fri. of every month as the time when I am going to do a month-end review of all financial, and other admin aspects of T-e, and during which I'll not be focused on anything, but T-e business; so I can issue myself monthly reports, to make it much easier for the year-end reporting to be done. That's tomorrow through this Friday, and I need to have the Valar images updated, and the Elvenchrist changes made before then. Having lost a day's work on the latter, I'm not investing any more time in this communication. You can't just fire someone the way you're trying to do to me; especially when the person hasn't intended wrongdoing.

What does the astrology of July 2020-November 2020 dictate that's on par with this

communication?

I've got work to do C; I'll have those Valar image updates to you tomorrow.

I am afraid that actually YOU are the one, Michaele Alyras de Cygne - YOU have undeniably violated many relevant sections of the Bylaws.

Article XVII regarding Conflicts of Interest, in particular 17.1, 17.1.1, (and 17.2.1 gives me the final authority that was hereby reached through sections 6.4, 6.4.1, and 7.1, and where, in this case, Article XX applies).

To further show Article XVII, please reference 22.1, where Jesus is outside of the Legendarium and you can personally honor him (and we make room for that inclusiveness for Christians so they feel included in ritual and unity with the Legendarium); but, founding another "ministry" in the fashion that you have done so (without prior consult, during nasty emails and texts, and clearly as a retaliatory and selfish reaction, rather than cooperation) and is such an irrefutable cause for your removal and discharge from the organization.

Remember, I have a copy of the ENTIRE chronology. Facts speak louder than feelings, even in light of your verbal abuse shown throughout this ordeal, even right now.

Particularly in this case, you are primarily leading from a base of fear. I felt that very strongly in you about Elvenchrist, and you didn't even bother to inquire of me about any of it as you were stewing about what you've below written. That must be a lot to bear, particularly because it's almost entirely driven by illusion. By the time I'm done with this message, you'll be strongly inclined to retract your position, and your below "directive", because, as you'll see, I haven't intentionally done anything wrong.

## You wrote:

"If you have done all of this for the Elven Spiritual Path, you did not run any of this by the Board, and I can tell you I would not have approved of this..."

Look at the Elvenchrist home page. It says "Elvenchrist is an extension of the ministry of

"<u>llúvamil</u>", (which is piloted by Tárainimë <u>Alysas</u>, one of the I Tárainimi who lead <u>Tië</u> <u>Eldaliéva Elven</u>

SpiritualPath (T-e) )"

This isn't about T-e, it's about Iluvamil, and that's stated UP FRONT, in the first clause of the first sentence of the only paragraph!!

Relative to placing several links to T-e on the Elvenchrist home page, where that's actually coming from is my boosting T-e's visibility, not the inverse. Yes, I establish the link between myself, and T-e, by direct association, however, that's neither competition, nor conflict of interest, but simple courtesy, and good public relations.

You cite conflict of interest; the only way there could be conflict of interest is if I was actually marketing the same

designs. Having a Redbubble store is competing on the same network no less than having a separate Youtube channel, or Instagram page, or any other profile on any other network to which also T-e belongs. Since I chose an entirely different commercial direction, and even used a different color septaquetra (to help to minimize the appearance of conflict of anything), there is no alleged conflict of interest on my part that would stand up in any law school class analysis, much less in a court of law. You're simply wrong about that, and about my intentions, and about my motivations, and everything else you've feared that led to such a mutual role-disrepecting communication as you've below delivered to me.

I don't need to run Iluvamil actions by the IC before taking them; period. There is nothing in our Bylaws that says that needs to happen; in fact, the Bylaws state that we are free to take external action without thereof violation, and without needing to have such prior consultation. Where are you coming from with that?

As for "this was all done in a spirit of nastiness and sarcasm, of which I have every email and cell phone text message you have sent to me to prove this"; the emails and texts you're referring to have not referred to Elvenchrist at all, and my position in them is that you're operating from a place of fear before fiduciary duty. You don't understand fiduciary duty as I do, because you have read the CA Attorney General's handbook on fiduciary duty that clarifies how many of your actions are contrary to that duty. You could not be farther from the Truth, and I hereby put you on blast about that:

Elvenchrist was inspired the first night after I left SF for MN; a whispered to me in that zone between sleeping and awakening. I checked on the domains a couple of days later, and bought the essentials, however, I let it rest beyond that because (A) I had a duty to the trust to give 100% of my attention to building our store, to getting it up and running, and to making sure that it was flying by Cueranyavannie. I wholeheartedly, and exclusively labored on the T-e store until I was done. Several days after finishing, [specifically, on 8/18], I delivered a list of the T-e Redbubble inventory to you, and that was when I was done with the T-e store. Having been fully, and

lovingly present through that workflow, I waited several more days before beginning to flesh out Elvenchrist; I needed to get the downloads about what to do with that.

On the 21st, circa 4 days after finishing the T-e store, (note the allowance of 3 days there), I got the first download, and it was to open an Elvenchrist store, however, to focus on exactly what I represent on the Elvenchrist home page; supporting Christians who walk the Elven spiritual path. That being a directive from Spirit, I've gone with it, for that demographic. That demographic is a subset of T-e, and the materials Elvenchrist is for them. The reason it's not on the Te store is the "Christ" part; i.e. avoiding our community fearing we're pushing a Christian sub-agenda. The entire business model for that is entirely different, and, since opening the Elvenchrist Redbubble store--in a spirit of cooperation, albeit not collaboration because T-e doesn't collaborate with Iluvamil!!!!!--I have taken GREAT pains, and invested a massive amount of hours into this: https://fineartamerica.com/profiles/elvenchrist-ministries -my choice as an alternate storefront, so as to further minimize the apparent conflict of anything between Iluvamil, and T-e.

Elvenchrist arises entirely, and exclusively from Love in support of the T-e membership that is also born again Christian. What I profess up front on the home is the whole Truth of it; any nastiness, sarcasm, or other negative intent is within your mind, completely exclusive of my mind. That being the case, what's going on in yours?

Illusion. I'm not responsible for any of it.

I'm not using T-e to catapult Elvenchrist; and, effectively, Elvenchrist is NO different than High Elven Wisdom and Love. I opened up all the accounts evident at the top of Elvenchrist home page within hours of each other, [since Saturday night], and only added brief bio's referring to T-e, and myself relative to T-e, on all of them. Last night, I put in "Elvenchrist" in DuckDuckGo, and up popped Elvenchrist's LinkedIn URL. I click on it, and WOW, I saw "Tie eldalieva..." effectively smattered there--which is THEIR presentation, not mine. **Bothered me a lot**, and I decided that I need to figure out how to revise that in order for people not to

get the impression that you apparently did by seeing it. I was working on building an alternate store to the Redbubble, <a href="http">http</a>
<a href="http">s://fineartamerica.com/profiles/elvenchrist-ministries</a>, to decrease the apparent "conflict of interest", (of which there is ZE-RO; I'll explain later.) That informed me that I need to follow up with all of those account, to ensure the same thing.

I'm very unamused by the LinkedIn presentation; despite my being pleased at the prompt, top of the list way their SEO process works. I'll be correcting that today, and ensuring that my other profiles don't do a similar thing (over the next couple of days). I'm not errant, or unethical in asserting my role, and relationship with T-e in my bio, and other material for Elvenchrist; that's a normal thing, and, if you had no problem with Kimberel doing likewise, which you did not, then, you should afford me the same respect.

Gosh, there's sooooo much other shit in your message that has no bearing in my reality. I'm sorry you're so burdened by all of the load that you think I am bearing, which I am not. I am simply doing my job, Calantirniel, and not allowing my conflicts with the way you wish to lead to be a deterrent, as much as possible. When you harbor such stuff, and allow it to build to such explosive levels, you make it difficult for me to do so.

This: "Much of this nastiness stems from the fact that you wish for the organization to reimburse you for expenses.." is also errant. You're trippin' about the trust reimbursing me exponentially more than I am even mildly concerned about it. The only aspect of my actions that's been fueled by my concerns about that was the timing of getting the store up. Since the store was a critical piece to our support, and growth process, hence also to eventually reimbursing me, I drove myself to ensure the store was happening on the last New Moon. Otherwise, I've not been harboring "nastiness" about it. The trust will reimburse me for the expenses I incurred in fulfilling my T-e duties, as they were defined in our

SD meeting, just as the trust would reimburse a consultant for the same work. The only error in my calculations in that regard was my assignment of a lost car part, which I have rectified. All other expenses are simply normal, and, I took great pains to ensure they were all as low as possible, even choosing motel rooms the shower curtains, and in one case, shower stall I had to clean myself. We crossed a bridge that will be crossed by others, and that's the context in which we should regard it.

As for the financial demands I have placed on the trust, invert that. I fronted the trust the funds that were necessary to get a critical job done, and I got the job done. I did so in full accord with the Bylaws. I did so in keeping with all best practices of business ethics, and fiduciary duty. I have not wronged T-e in any way, in that regard, but profoundly furthered the organization in manifold ways the value of which far exceeds the monetary value of my expenditures. That's a fact. My having unilaterally decided to defer any reimbursement to after Aug. 1, 2021 is further indication of my behavior not intending to cripple, weaken, or otherwise compromise T-e financial position--surely, in that time, the trust will have those funds--if I was a contractor, the trust would be obligated to pay up within 90 days.

Where are you coming from with this: "Despite the fact that the Tengwar merchandise is horribly wrong, you didn't care and tried to justify it, when it wasn't even CLOSE to being right - and then you added things to the website anyway, not waiting for the experts who graciously gave their time and effort to help us."?

Did you miss my email about the offline, and online rendering conclusion? No. Was that not a remarkable effort, on my part, demonstrating care? I think so. Did I not say take several days to do your investigation, and did I not say that I would be willing to update the linear Valar art, but not the circular because the circular would take far too much time? Yes. Is that being care-less? No, it's not being so. WHAT did I add to the web site???I don't recall making any changes to the web site for the past week, since before you contacted your experts. Where are you coming from with that entire accusation?--it's not from my

actions, that's for sure. I've offered to help, and my resistance to you pulling the Tengwar was based on best business practices, i.e. preferring to gain the added traction from product visibility, not to being corrected, or to needing to update the art. Given an inconclusive determination, I felt you were being unreasonably fearful not to abide by those practices, and I still believe that fiduciary duty dictated running with the product visibility, and pulling them later, offering a retraction if necessary was the best course of action. We may disagree on that; that's fine; we don't disagree about the results of the experts, which I have read in your subsequent message.

I'll make the linear art changes to the Valar art images in the next couple of days.

As for this, "Because I am a fair and compassionate person, I will give you an opportunity to step down, and to not cause any more trouble in the organization. I recommend it to keep any shred of dignity, as well as avoid further action"; *bloody unnecessary*. I haven't done anything undignified, and I haven't caused any trouble for the organization; Calantirniel, during the past month, I have ONLY had conflict with your leadership style, and I have not allowed that conflict to impose itself on my fulfillment of any of my trustee duties, to the best of my ability.

The root of my recent conflict with you is you attacking me about the expenses I've incurred in the course of the Triage resolution. That word is apt, it was a verbal attack; you yelled at me for upwards of 40 minutes about it, and, near the end of that period, you crystallize your point as fear that I had put you, and Dave personally at risk, believing that, if the trust couldn't reimburse me, that the debt would fall to you two. That fear is what drove that attack, and it didn't quell until I loudly insisted that the trust's debts do not,

in any way, carry over to the trustees. My nervous system was totally shredded by that. In that conversation, you gave me a directive--[repeated info here]-- to stop spending funds on Triage actions. For me that was like a giant coming in stomping in the middle of my train tracks within line of sight of my destination, putting me in dual conflict with the first directive, (1) my fiduciary duty dictated that the

destination had to be reached, (funding partially depended on the store, and the final step was in sight, requiring only a few more days of motel stay, and (2) my Opportunity Generator momentum had to play out in a way that accommodated it. I worked that out, and fulfilled my duty, and the store went up, and we're getting more attention. I spent the subsequent interim between that experience, and getting the store up with no call, no text, no contact from you inquiring about how I was doing, without an apology [that I've seen] for that attack, and without support for my part of the process—as you were ruminating on the slew of illusion arising from my apparent literary tone, without calling me to talk about any of it.

As for my Triage expenditures not being approved, I have already been over that; our Bylaws permit department heads to unilaterally act, without prior consultation with the IC. My reasonable expenditures fall in that category. (And, once again, having stated this before, my simply moving forward unilaterally wasn't my being underhanded, or sneaky was largely driven by compassion for you, Calantirniel, and not adding unnecessary weight of my decisions to your plate--you simply did not need to weigh in on them, and the weight of what was on your plate had already reach exasperating gravity.) As regards receipts, I

thought I had clarified for you that I use my bank statements as receipts, and that I would gladly include the full bank statement record of each relative transaction in the full, year-end accounting. I also clearly indicated that the partial citations present in the Annual Report finances compilation .xlsx file were representative of the veracity of those transactions. The IRS will fully accept those, so everything is on the up, and up there. As I write this, here in MN of all places, an eagle just flew overhead, and called; seems to inform me of the rightness of my behavior, and the incorrectness of your perspective.

There's so much more that you've below written for me to address, however, it's more outpouring of the illusion stew, it's not based in fact, or reality, or even Love, so, I'm just going to leave it. You owe me a compound apology, Calantirniel. In light of the above, I'm going to ignore the below, and continue fulfilling my roles as a member of the I

Tarainimi. Moving forward, I encourage you to directly ask me about what you suspect about where I am coming from before allowing the illusions of where may be coming from to rise to the point of such toxic intensity.

It's been very unhealthy for you to carry all of this, especially to the point where you felt you had to issue such a compound demand. If there is any selfish intent in my Elvenchrist store, it's that the store will unilaterally enable me to restore what I have invested in T-e, so it won't matter how long it takes for the trust

to reimburse me. Now, learning that, I invite you to totally rethink your position.

As Director of Operations, Treasurer, and Director of Music Ministry, I have a lot that I need to do to structure our organization to succeed after I eventually leave each of those roles. Presently, there is no need for me to leave, based on the falsity of the points you cite as cause for you to write what you

have below, so I'm going to continue focusing on figuring out how to devote regular time to fulfilling each of those roles in ways that produce consistently progressive results. I hope you both have a very good day.

Alyras, Michaele de Cygne, you are hereby on notice that you are to immediately vacate your position as the I Tarainimi which is including but not limited to your position

as the Treasurer of Tië eldaliéva, the Elven Spiritual Path Spiritual Organization and Charitable Trust. (hereinafter referred to as the Elven Spiritual Path)

This has been an inevitable decision that has caused me great pain, since for many years we had been able to work together, and since July of 2020, you have acted in ways that are just not in the best interest of this organization.

The biggest reason is, within the last two days, you have opened Elfchrist.com - basically as a store, with a full website and social media that is most definitely in conflict of interest. If it is for yourself, you are using the Elven Spiritual Path in all of your branding, thereby confusing people so that they would think they are supporting the Elven Spiritual Path, where they would really be doing business with a deceptive competitor. I have screen-shot everything and can prove this without a doubt. Not acceptable.

If you have done all of this for the Elven Spiritual Path, you did not run any of this by the Board, and I can tell you I would not have approved of this, but rather would have encouraged a new collection in the same store, rather than create a different one.

I asked Dave what he would have done, and he said he would have preferred my idea of unity, not divisiveness, and also sees how this is confusing to people. And this is also not acceptable.

We have no problem with people who are in a spirit of collaboration, but this was all done in a spirit of nastiness and sarcasm, of which I have every email and cell phone text message you have sent to me to prove this.

Much of this nastiness stems from the fact that you wish for the organization to reimburse you for expenses, some of which were verbally approved by us but we do not yet have the funds and may not for some time, and others that were not approved. However, requesting receipts is not just to hassle you, it is actually a mandatory practice. If the IRS were to ever audit us, every kind of company, for profit or otherwise, would need to be able to show receipts, and if there are not physical receipts, that you use bank statements (with private stuff blocked out understandably) or request duplicate invoices. Now, for mailing and copies when they are under like \$10 and I recall items being printed, copied and mailed, I can understand it may not be worth tracking those receipts down, but others are well worth the efforts if the IRS would ever audit us.

So, along with your huge, unignorable conflict of interest (which is the biggest reason we are asking you to leave, and this decision is non-negotiable at this point), is that not only have you placed heavy demands financially on our organization that no other board members do at this tender, early point in the organization's development, but you have been demanding me to operate the Elven Spiritual Path in a way that is illegal by refusing to provide me with the things (receipts) that the IRS would need.

And in the meantime, you have been acting in ways that could be seen as resistant, demanding, unreasonable, noncompliant, and even at times irate and belligerent. In wishing for quality (accurate) merchandise to be available, you have literally been impossible to deal with. And more than once, you do things I have specifically had reasonable problems with (a good example is the Tengwar issue email which is sent at around the same time as this demand for you to vacate). Despite the fact that the Tengwar merchandise is horribly wrong, you didn't care and tried to justify it, when it wasn't even CLOSE to being right - and then you added things to the website anyway, not waiting for the experts who graciously gave their time and effort to help us. This is truly unacceptable on every level. We cannot have an organization that runs in the spirit of such negativity, and it ends today.

If your behavior is inadvertent, it would show you are incompetent and incapable of responsibility of the position (no matter what the reasons are). If your behavior is deliberate, it is even more of a reason to ask you to leave. None of these are even remotely acceptable.

Because I am a fair and compassionate person, I will give you

an opportunity to step down, and to not cause any more trouble in the organization. I recommend it to keep any shred of dignity, as well as avoid further action.

We obviously need to make arrangements for the rest of the transfer of things back to the organization, and to make a payment plan that is reasonable and doable for reimbursement of APPROVED expenses (with receipts) you have incurred. For these purposes, my email will be open to you. At this time, we have approximately \$245, and are receiving at the current rate about \$1500 per year (not counting expenses), and I hope that grows soon.

I realize there are other things to negotiate, such as:

- 1. We keep the 501(c)3 since it was funded by those who wanted this organization to come to life after 15 years, and we request that you have back your non-profit we had absorbed into it (the National Suicide Prevention Directory), since that seems right.
- 2. I would like you to change the name of the Elven Spiritual Path YouTube channel you made. The symbol is okay.
- 3. We keep the terms Tië eldaliéva, the Elven Spiritual Path, and Elven Spirituality, and Yana eldaliéva (and relevant terms for the physical buildings that are to come). We can negotiate to use

(or non-use) of other terms, like the I Quendi through Hera I Tarainimi, and whether these terms are exclusive, etcetera.

- 4. I request the paper documents that form our organization, as we may need to change the Bylaws and other documents. If you would rather us handle this electronically, we can figure something out but to my knowledge, I didn't receive a full copy.
- 5. We are willing to not use (or provide back) material that you provided, and are willing to credit you for material that you wish for us to have in our history. If you use our

material, we would ask for credit for the parts that were sourced through our work. As for the septaquetra, that is public domain. As for the T-e seal, we can get a different artist and cease using it if you wish this. We can go through these and figure it out (i.e. Linde Elenlote video).

I will be traveling to Montana for (at this point) an indefinite period of time, but I will have internet access and check email regularly. As painful as all of this is, I do hope both of us find healing and forgiveness in this process of separation, and that love can be the balm that heals the wounds that are honestly pretty fresh right now. Laita - I wish you well.
